### Case Summary

I responded to the above address for a death report on a 15 years of age female. When I arrived I was told that approximately 3 days earlier that the deceased and 5 other family members had suddenly started having severe nausea, vomiting and diarrhea. I was told that it was felt that they were suffering from some sort of food poisoning. Within 24 to 36 hours all but the deceased started to feel better. The deceased continued to suffer from the above described symptoms and became weaker over the next several hours until she was unable to attempt to eat or drink. She gradually became more lethargic and slipped into unconsciousness. She remained in this state for 4 to 5 hours and went into cardiac arrest. The deceased had no history of any other health issues prior to this. I advised the family that under the circumstance, her age and the suddenness of onset of the illness, I was going to order an autopsy to determine the cause of her death. Due to the number of family and friends at the residence, I chose to postpone any further physical examination until the autopsy. Dakan Funeral Home was requested to make removal of the body.
